

The following stated policy has been established as a guideline when considering individuals for membership in the Rotary Club of Medford.

- Membership in a Rotary Club is considered to be the personal membership of the individual and not the membership of the firm, company or organization which the individual represents.
 Therefore, in considering an individual for membership certain points should be determined:
 - a. The individual's character and reputation are above reproach.
 - b. The reputation of the individual's firm, or organization in the general community, or competitors and those with whom the firm deals should be above reproach.
 - c. The individual is "service minded".
 - d. That the individual be able to attend weekly meetings on a regular basis.
 - e. That the individual be able to meet the financial obligations or membership.
- 2. Unquestionably, in order for one to arrive at the correct answers to aforementioned points, a period of several months' knowledge (acquaintance) would be required. There are, of course, exceptions, such as:
 - a. Individual has been transferred to the area by an established firm, e.g., bank, utility chain store, etc., and referenced firm can provide necessary background information.
 - b. Individual has moved to the area and has been a member of Rotary in previous location(s) and in engaged in the same line of endeavor, i.e., would have the same classification as previously held.
 - c. Individual can provide certification of membership in a prior club that he/she has no prior indebtedness to prior club.
- 3. Therefore, in order to prevent unnecessary termination of membership, individuals to be proposed for membership should have resided in the club area for at least six (6) months or qualify for an exception as listed in paragraph 2, above, before being proposed.
